History Snap Shot of Salem Church Building Projects As written by Lena Tremeer (1878 – 1956)

The original log church and a shed were built in the mid 1800's on the southeast corner of the cemetery. In 1860 the first Sunday school was organized. A second shed was built to the north of the church in 1881. In 1884 an organ was purchased. In 1885 the lot where the church now stands was purchased for \$60. A church and sheds were purchased in Little Britain for \$400, taken down and moved to the new lot. The log church and sheds were also taken down.

The church was rebuilt and was opened in December 1885. The total cost; land, church, sheds, and fence was \$1800.

In 1909, the brick porch at the front of the church was removed and replaced by the concrete steps. The cost to the church was for the cement and one man to lay out the forms.

In 1926 the old shed to the north of the present church was taken down and the steel clad shed was built. The total cost was \$1600.

Accomplishments

- Canadian flag markers were placed on gravesites as part of the Memorial Decoration Day Service to honour war veterans buried in the cemetery. Please inform Jim Tremeer of names of other veterans to be included in this annual acknowledgement (905-722-3117).
- Application for Charitable Registration was submitted to Canada Revenue Agency. The process to determine qualification for approval will take several months.
- Tree work was conducted in the church grounds, trimming the maple trees to prevent damage to the church roof and to facilitate parking for the Annual Service.
- Pest Control work was completed to deal with the problem of bees at the church door/attic areas.
- Annual Cemetery Owner Information Report 2010 was filed with the Ontario Ministry of Consumer Services, Cemeteries Regulation Unit.
- Stairs
 - Glenn Wilcox (Architect) has been retained to supply drawings and designs, as well as guidance for the application to the Trillium Foundation.
 - A set of temporary steps and railings will be installed in the spring for access from the east side of the existing steps.
 - Warning signs have been posted at the church to notify of "Use at own risk".
