On the Third Monday in June, from 1860 to 1951, the Salem Mariposa Sunday School held a salad supper in the church basement. This was the biggest fund raising event of any of the church activities each year. All the women and men of the church congregation and Sunday School pitched in to provide large amounts food and labour to make this event a success.

The tables were set up, tablecloths were spread out, plates, a cup and saucer and silverware arranged at each place setting, decorations were arranged and a chair set to each place setting on Saturday afternoon. I estimate that between 50 and 60 people could sit at each sitting and that there would be at least 3 full sittings.

Some things were not the most convenient; hot water for washing dishes had to be heated on an old stove in the cookhouse on the eastside of the lot and carried over to the pantry. The tea and coffee were made in the cookhouse and carried across as needed.

A refreshment booth, that sold pop, ice cream, chocolate bars, popcorn etc. was in the open shed and for many years there was a ball game across the road for early evening entertainment.

After everyone was served supper and the dishes were washed, an evening of various entertainments was held in the big steel shed each year.

This was a community event that drew people from all over the area and other churches every summer; everyone looked forward to this supper every year.

- New Church Steps: Successful demolition of the old concrete steps and installation of approved pressure treated wood system and new concrete sidewalk. Thanks again to "Th Crew". Please check the website for additional pictures.
- In 2004, Ian Campbell, Chair of the Salem Church & Cemetery Board of Trustees, initiated the process of historical designation for Salem-Mariposa United Church within the municipality of City of Kawartha Lakes. The project was completed by July



2005 and the dedication ceremony took place during the memorial decoration service of that year, including the planting of six heritage Canadian sugar maple trees in the churchyard. A commemorative plaque was presented to Board member Everett Davey by Bill Bateman, Chair of the Heritage Committee (see adjacent note) for City of Kawartha Lakes on July 21, 2013. The plaque will be mounted permanently on the north side of the church near the new steps.
