#### **CONDITIONS AND TERMS:**

If the above Interment Rights have <u>not</u> been used, the Purchaser may in writing to the cemetery operator within thirty (30) days from the signing of the contract cancel this contract and receive a full refund.

Written consent of all surviving Rights Holder(s) and any other required documentation as set out in the cemetery by-laws is required for interments, cremation, disinterments, and the placement of markers, monuments, or inscriptions.

Salem-Mariposa Church Building & Cemetery PERMITS the private resale of Interment Rights after 30 days.

A purchaser or interment rights holder cannot re-sell their Interment Rights for more than the current value on the cemetery price list.

A purchaser or interment rights holder cannot re-sell their Interment Rights if a portion of the interment rights have been exercised.

No Rights Holder(s) may sub-divide and sell or transfer a portion of an Interment Rights.

Before a re-sale of an Interment Rights may take place the original Interment Rights Certificate must be returned to Salem-Mariposa Church Building & Cemetery or a fee remitted, according to the cemetery price list, for a replacement certificate.

Before a re-sale of Interment Rights may take place a 'RESALE ENDORSEMENT' form must be completed.

#### Memorialization:

In accordance with the Funeral, Burial and Cremation Services Act (FBCSA) and Ontario Regulation 30/11, the following contributions will be made to the Care and Maintenance Fund for every installation of a marker or monument:

(a)	In the case of installing a flat marker measuring less than	
	1,116.3 sq.m. (173 sq.in.)	\$0.00
(b)	In the case of installing a flat marker measuring over	
	1,116.3 sq.m. (173 sq.in.)	\$100.00
(c)	In the case of installing an upright monument measuring	
	1.22 m. (4 ft.) or less in height or length, including the base	\$200.00
(d)	In the case of installing an upright monument measuring more	
	than 1.22 m. (4 ft.) either in height or length, including the base	\$400.00

A marker, monument, or memorialization purchased and/or installed by anyone other than the Rights Holder(s) may be removed by the cemetery staff on the written request of the Rights Holder(s).

## Cancellation of contract within 30 days:

The following person may cancel a cemetery contract within 30 days and is entitled to a refund:

- The purchaser [individual paying] of the Interment Rights.
- If the purchaser is different from the Interment Rights Holder(s) it is the purchaser who is entitled to the refund. The Interment Rights Certificate must be returned at the time of refund.

## Cancellation of contract after 30 Days:

Salem-Mariposa Church Building & Cemetery does not honour any refunds after 30 days; however the interment rights holder is permitted to make a private resale or transfer arrangement of Interment Rights as per Section C of the Salem-Mariposa Church Building & Cemetery By-laws.
